## ASX Announcement

### Section 708A Cleansing Notice and Appendix 2A

**Melbourne, Australia:** Engineering product and solution provider, Synertec Corporation Limited (ASX: SOP, "Synertec" or "the Company") has today issued 5,000,000 fully paid ordinary shares ("Shares") and received the sum of \$180,000 upon early exercise of unlisted options (ASX:SOPAB) at an exercise price of \$0.036 per share with an expiry date of 24 August 2021. These options were issued as settlement of the fee for the share placement ('Placement') undertaken in July 2020 and were approved by shareholders at the 2020 Annual General Meeting.

This notice is given by Synertec Corporation Limited (ASX: SOP, "Synertec" or "the Company") under Section 708A(5)(e) of the *Corporations Act 2001 (Cth) (Corporations Act)*.

The Company hereby confirms that:

- (a) it has issued a total of 5,000,000 fully paid ordinary shares (Shares) at an issue price of \$0.036 (3.6 cents) per Share in relation to the exercise of unlisted options;
- (b) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (c) the Company is providing this notice under paragraph 5(e) of Section 708A of the Corporations Act;
- (d) as at the date of this notice the Company, as a disclosing entity under the Corporations Act, has complied with:
  - i. the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
  - ii. Section 674 of the Corporations Act as it applies to the Company; and
- (e) as at the date of this announcement, there is no excluded information of the type referred to in Sections 708A(7) and 708A(8) of the Corporations Act.

The proceeds from these options, coupled with existing funds, contribute further to the Company's strong cash position enabling it to continue to pursue several large near-term key technology opportunities in the energy sector including:

- Composite Dry Powder ('CDP') for the environmentally-friendly and economic treatment of oil and gas drilling mud;
- Custody Transfer System ('CTS') for precise, safe and environmentally-friendly LNG transfer, for both land and marine based applications; and
- Other related technologies with application into the global energy market which provide important environmental and economic benefits over current practices.
